## **Director's Report:**

Grants - Update on North Country Wild Care Grant for caging

Rod distributed the grant application/photo for a large mammal cage (to include deer). Total cost is \$2,758.63. Discussion took place regarding an electric fence to protect the caged animals. Rod will adjust the grant to include the electric fence. Rod will submit the grant soon.

## Volunteers for rehabilitation of animals

Insurance for volunteers - Jenny checked with her insurance agent for coverage. \$5,000 to start for minimum coverage. Due to high cost, Jenny will not provide insurance and volunteers will need to sign a waiver. Wendy shared an example of a waiver from <a href="mailto:Animalkind.NY">Animalkind.NY</a> Jenny will create a waiver. Current volunteers: Abby Vandewalker and Joe Oathout

## Reimbursements

Check #263 was written in the amount of \$1,157.25, to reimburse Jenny for rehabilitation supplies and kayaks for the Poker Run.

# **Building of Habitat Structure- Rod Lang**

Discussion took place regarding possible solutions to move the habitat structure. Tentative date to start the process of moving the shed - July 22nd @ 6 PM. Where the building will be placed will be determined prior to July 22nd.

## Waterway Cleanup - Matt Sullivan/Chair, Dickie Hart and Larry Smith/Vice Chairs

Larry, Matt, Wendy, Bob Conklin, and Lynn Morck worked for an entire day to clear the waterway from the first bridge of the West Branch to Mel's place. A week later, Wendy, Deb, Margaret, and Barb Luthi checked the waterway. It is currently passable, except for the beaver dam past the 2nd bridge (the beavers rebuilt what was cleared by the initial cleanup crew). That area will need to be cleared prior to the Poker Run. The waterway is low in some areas. Larry suggested raking out small channels if needed. Larry also suggested an additional cleanup day after the Poker Run to remove debris on the banks of the river. Winches are needed to make the work faster and easier. Dickie will look for a rope donation.

## Wildlife Rescue - Monthly intakes, stabilizations, releases - Jenny Smith

All cages are full. 2 skunks stabilized. 1 opossum stabilized and transferred. 1 rabbit and 2 squirrels are ready for release.

Jenny has developed a good rapport with DEC in both Montgomery and Hamilton counties.
